State Spotlight: Washington (p. 1)

Cross-Divisional Alignment Across All Monitoring Activities:

- Coordinated Risk-Based Data Analyses to inform selection for monitoring.
- Monitoring notifications include option to combine special education with other federal program monitoring.
- Co-designed monitoring visits combining special education and other federal program monitoring, when possible.
- Uniform monitoring platform for district submission of monitoring information, reviewer responses, and final reports.



State Spotlight: Washington (p. 2)

Coordinating School Improvement & Special Education Priorities:

- ESSA's opportunity: Re-envisioning special education indicators.
 - LRE Data Platform: unsuppressed, building-level special education demographic & outcome data, including placement, disproportionality, and school improvement designation.
- Braided funds to support school improvement and special education collaboration, including staff time, professional development, and co-planning and implementation.



State Spotlight: Utah (p. 1)

Consistent LEA fiscal monitoring protocols including a cross-team review of fiscal monitoring results (financial operations, special education, and federal programs)

- Standard Operating Procedures (SOPs) for all aspects of the process
- Standard letters of engagement/request for information, findings of noncompliance and required corrective action, and closure of correction action.
- Standard protocols for site visits



State Spotlight: Utah (p. 2)

- Supports (large group and individual LEA technical assistance, templates, and networking connections with other LEAs) from the School Improvement (SI) team provided to LEA Special Education Directors about how to use IDEA funds to support TSI exit activities
- Supports (large group and individual LEA technical assistance, templates, and networking connections with other LEAs) to improve the achievement of students with disabilities from the special education team provided to LEA Title I Directors, and school leadership teams and technical assistance for how to use IDEA funds to support TSI exit activities



State Spotlight: Utah (p. 3)

2022-2023 "Integrated Coaching" Pilot (Integration of TSI and RDA)

- 7 schools identified for TSI for students with disabilities (SWD) who also are in LEAs with high risk in the special education Results Driven Accountability (RDA) rubric were offered systems coaching from a pair of USBE staff including a school improvement and a special education team member. Five schools participated.
 - 1 suburban comprehensive high school
 - 1 rural charter school
 - 2 suburban middle schools
 - 1 suburban elementary school
- Coaching activities included, review of all available data, review of all school and LEA improvement plans, administration of WestEd CALL survey, update to TSI school improvement plan, professional learning related to the priorities outlined in the school improvement plan
