Session Description

This Implementation Session brings inclusion data and research to life to consider state, local, and environment factors influencing the advancement of equitable, high-quality inclusive opportunities for young children with disabilities and their families. Presenters representing unique, systems-level perspectives will review national inclusion data trends and outline examples of experience-based, proven strategies for dismantling commonly referenced early childhood inclusion barriers.

- Presenters will acknowledge the challenges associated with implementing high-quality inclusion while also inviting and supporting participants to consider obstacles as opportunities through which creative, collaborative, and sound solutions can be discovered and implemented.
- Examples of solutions ranging from policy efforts to professional development practices will be
 presented, and guided discussions will occur throughout the presentation to promote the coconstruction of applicable solutions that session participants can use to inform their own states,
 programs, and/or environments to begin working toward transformational inclusive change
 that leads to improved outcomes for young children with disabilities and their families.
