# Why Are We Modernizing EDFacts?

- Technical reasons: age, security requirements, technology
- Operational reasons:
  - What was not working?
    - Post-submission data quality process was unsustainable and inefficient (ED responsibility)
    - Data not usable at the due date (SEA responsibility)
- Priorities
  - Fix ED data review-and-use processes
  - Provide tools to support <u>State</u> processes
  - Use data at the due date



### Expectation under EDFacts Modernization

- OSEP expects states/entities to take one of the following two actions for all business rules that are triggered prior to the due date:
  - 1. revise the uploaded data to address the edit; or
  - provide data note addressing why these data submission has triggered the edit.

Please note that, for data submitted via EDPass, you will be unable to submit the data to ED without taking one of these two actions.




### New for SY 2022-23 IDEA Section 618 Data

- Submit the majority of 618 Part B data via EDPass
- Due dates have been adjusted
- Address business rules that are triggered prior to due date
  - Business rules results (also referred to as data quality results)
    - Results will be downloadable
  - Business rule response options
- Submit all required levels of a file at the same time (i.e., SEA, LEA, and school level, as applicable)
- Submit data notes prior to due date
- No resubmission period

### **EDPass Close**

- Due date was May 10 for 7 SY 2022-23 files:
  - FS029 Directory
  - FS039 Grades Offered
  - 5 Charter files
- >130 business rules implemented
- All 60 entities submitted by the due date

- 13 Entities with <20 errors</li>

Many large counts for the 5-year Charter Contract error that skews results

- Using the Business Rules Single Inventory to prepare data submission
- Developing high quality data notes

# How are the 618 data used in SPP/APR & IDEA Determinations Process?

- Prepopulated for indicators:
  - 1 Part B Exiting data
  - 2 Part B Exiting data
  - 3 Assessment data
  - 5 Part B Child Count and Educational Environments (school age) data
  - 6 Part B Child Count and Education Environments (preschool) data
  - 15 & 16 Part B Dispute Resolution data
- Used in the data rubric:
  - Evaluation of the 618 data submissions for timeliness, completeness, and accuracy (i.e., passing edit checks)
- Used in the Results Matrix:
  - Part B Exiting data
  - Part B Assessment data

### Data Rubric

- OSEP uses the Part B Timely and Accurate State-Reported Data Rubric in the SPP/APR to award points to States based on the timeliness and accuracy of their sections 616 and 618 data. A copy of the rubric is contained in the OSEP Response to the State's SPP/APR. The State's section 618 data is scored based on information provided to OSEP on section 618 data timeliness, completeness, and edit checks at the due date.

- Data quality reports provided after the due date represent data quality ratings for the purpose of the data rubrics. Once you receive the data quality report from OSEP, please contact OSEP via Partner Support Center if you would like to dispute the data quality ratings for that data submission.

# Data Quality Checks

- Business Rules Single Inventory
  - Column F (EDPass Rule ID) search for "IDEA"
  - Column N (FS) file spec number as applicable
  - Column R (Definition) review to understand the rule
  - Column V (Error Message) review to understand the rule
  - Additional information:
    - Columns J, K, & L which level of the data the rule is applicable to
    - Columns T & U thresholds for the rule
    - Column S rule logic
- Note: For collections in EMAPS, the User Guide provides the data quality checks as well.



# IDEA Section 618 Data Quality Ratings for SY 2021-22 Data Submissions

# Tips for Addressing Commonly Activated Data Quality Checks

- Ensure metadata matches data reported (or a clear explanation is provided for why the mismatch is occurring)
- Report zeros for permitted values/ combinations of permitted values that are applicable to your state at the SEA level
- Do not report zeros for permitted values/ combinations of permitted values that are not applicable to your state.
- Ensure:
  - Detail counts = subtotals
  - Subtotals = grand totals
     (or provide a clear explanation why they do not equal)



### Year to Year Data Quality Checks

- Suspended for 20/20% Year to Year Edit for SY 2022-23 data submissions
- OSEP will review for egregious errors, such as switching of reporting categories; reporting exactly same data as the previous year
- For Dispute Resolution:
  - Year to Year reports will still be produced in EMAPS.
  - \*\*\* States are encouraged to review these reports to ensure there are no data entry errors.\*\*\*
- NOTE: OSEP will conduct the Year to Year edit for FFY 2022/SY 2022-23 MOE and CEIS data submission



### Process for Submitting a Data Note

- Modernized process for SY 2022-23
  - Data notes are entered in EDPass and submitted with the data to OSEP
    - Do not upload data notes to OMB Max!
  - Applying a data note to a specific DQ rule failure or multiple rule failures will resolve the DQ error and prepare the data for submission



# High Quality Data Notes

- Speak explicitly to the data question raised.
- Provide reasons for data anomalies when possible.
- Speak to policy changes.
- Note implementation changes that could affect data.
- Comment on next steps.
- Provide detailed contextual information that allows for improved use and interpretation of state submitted data.

### Data Note #1: Is it sufficient?

### **Error message**

 IDEA-0003: The sum of Children with Disabilities (IDEA) School Age in one or more categories sets or subtotals that include all students did not equal the EUT.

#### Data note

 The count of males plus the count of females does not equal the total number of children with disabilities reported for this year because our state allows students to report gender under a non-binary gender reporting option. 100 children with disabilities were reported in the non-binary gender reporting option as of this year's child count date.



### Data Notes #2: Is it sufficient?

### **Error** message

 IDEA-0001: A count of Children with Disabilities (IDEA) School Age was not reported for one or more permitted value combinations used by the SEA where zero reporting was required.

#### Data note

Data are accurate as submitted.



### Data Note #3: Is it sufficient?

### **Error** message

 IDEA-0005b: The Children with Disabilities (IDEA) School Age file contained all -1s.

#### Data note

 We are unable to submit these data at this time.



### Data Note #4: Is it sufficient?

### **Error message**

• IDEA-0002: A count of Children with Disabilities (IDEA) School Age was reported for one or more permitted value combinations not used by the SEA where zero reporting was required.

#### Data note

 There were 3 children who were age 7 and still identified as having development delays as of the state child count date (Oct 1) this year because they started in a new district this year and new district did not have time to identify a new primary disability category for these children.
