#### Purpose of the Personnel Development Program

The purpose of this priority is to fund a cooperative agreement to establish and operate a National Technical Assistance Center to Diversify the Workforce Serving Children with Disabilities (Center) by supporting HBCUs, TCCUs, and other MSIs that offer high-quality degree or certification programs in early intervention, early childhood special education, special education, or related services.



#### Award Information

- Awards are for a maximum of \$1,500,000 per year for 5 years.
- This program uses an unrestricted indirect cost rate.
- This program does not include any program-specific limitation on administrative expenses.

# Adequacy of Resources and Quality of Project Personnel: Application Requirements

#### Demonstrate how the proposed project will ensure.....

- applications for employment from persons who are traditionally been underrepresented
- key personnel have the qualifications and experience to carry out the project and can manage the project in a way to achieve objectives
- ▶ the time commitments of key personnel are adequate to meet objectives
- the proposed project will have processes, resources, and funds in place to provide equitable access for project staff, contractors, and partners, who require digital accessibility accommodations; and
- costs are reasonable in relation to the anticipated results and benefits.

# General Requirements & Assurances

- Make positive efforts to employ and advance in employment qualified individuals with disabilities
- Involve individuals with disabilities, or parents of individuals with disabilities ages birth through 26, in planning, implementing, and evaluating the project
- Maintain high-quality website
- Budget for attendance at in-person kick-off meeting, Project Director's meetings, and additional Department briefings or conferences
- ▶ Budget for a 5% set-aside as described in the NIA



# General Requirements & Assurances, cont'd

- ▶ Engage doctoral students or post-doctoral fellows, including those who are multilingual and racially, ethnically, and culturally diverse, in the project to increase the number of future leaders in the field who are knowledgeable about digital accessibility and related technologies in educational and early-learning contexts;
- Include, in Appendix A, an assurance to assist OSEP with the transfer of pertinent resources and products during the transition to a new award at the end of this award period, as appropriate.

# Subgrants and contracts

- ▶ Under 34 CFR 75.708(b) and (c), a grantee under this competition may award subgrants--to directly carry out project activities described in its application--to the following types of entities:
  - IHEs,
  - nonprofit organizations suitable to carry out the activities proposed in the application, and
  - public agencies.

The grantee may award subgrants to entities it has identified in an approved application or that it selects through a competition under procedures established by the grantee, consistent with 34 CFR 75.708(b)(2).

# Application Submission

- ► Applications must be submitted electronically using Grants.gov.
- Applications may not be submitted via email.
- Applications must be submitted no later than 11:59:59 p.m., Eastern Time, on May 15, 2024
- Application narrative sections and all other attachments to the application must be uploaded as a PDF (preferred) or Microsoft Word file.
- Format narratives and attachments with accessibility in mind.



# Submission Tips

- Register early. Grants.gov may take five or more business days to complete. Be sure that your registration with the System for Award Management (SAM) is current.
- Submit early. Don't wait until the last day to submit your application. Grants.gov will put a date/time stamp on your application and then process it after it is fully uploaded.
- ▶ Verify submission is ok. Verify that Grants.gov received your submission on time and that it was validated successfully.

- Maximum funding levels for each grant are noted in the notice.
- <u>Recommended</u> organization, page limits, spacing, and font sizes facilitate the application review process.
- PDF files facilitate the consolidating of application elements and review process.
